HOW AND WHERE ARE THE HEARINGS HELD?

The hearings are held at one of the Idaho juvenile corrections facilities in person or by video. If you're not located at the facility where the hearing is in person, you will participate by video.

HOW OFTEN DO CRB HEARINGS OCCUR?

The CRB meets four times a year.

WHEN WILL THE OUTCOME BE KNOWN?

The CRB's determination will be sent to the director of IDJC. Shortly thereafter, in writing, the director will notify the appropriate parties of the Board's recommendation in the matte

CRB REVIEW HEARING



What is the CRB?

WHAT IS THE CRB?

The Custody Review Board (CRB) was created to advise the Director of the Idaho Department of Juvenile Corrections whether, in their opinion, the youth before them need extended time in custody to address competency development, accountability and community protection needs. The board members are not judges, but members of your community.

WHY AM I GOING TO THIS HEARING?

If you are no more than six months from your 19th birthday and one or more treatment team members believes you need extended time in custody beyond your 19th birthday, you must be seen by the CRB at least once.

OR

If your program time is expected to go past 18 months.



WHAT IS EXPECTED OF ME?

- 1. You will be asked to write a letter prior to your hearing about how you are doing in program and what your future plans are.
- 2. In addition to your letter, you will be able to tell the CRB about any updates to your program progress or aftercare plan on your hearing day.
- 3. The CRB may ask you questions for additional information.
- 4. After the hearing, you will return to your group and continue with the daily program schedule.
- 5. Continue program and wait for the written notification letter.

WHAT IS EXPECTED FROM MY TEAM (Group Leader, JSC, JPO)?

- 1. Your team was asked to submit information about your program progress and aftercare plan.
- Your team may talk during the hearing about any new progress or aftercare changes and answer questions from the CRB.
- 3. The CRB may ask your team questions for additional information.

WRITING MY CRB LETTER

What's the purpose of writing a letter to the CRB?

- share how you're doing in program
- inform what still may need to be done
- inform the CRB about your future plans

You may include the following items in your letter:

- program progress/challenges/achievements
- how you have changed or grown in program
- school progress/challenges
- · relapse prevention plan—status and use
- aftercare plans
- readiness for change
- how close you are to program completion
- future plans (school, job, life, etc.)

During the hearing:

- be respectful
- be honest
- speak slow and clear (to help video connections)
- only the board can ask you and your team questions
- answer all questions truthfully
- remain quiet until it is your turn to talk
- talk about your strengths and challenges

Remember, the board is not out to get you.

They want to learn about you.
